The Court finds that, in that COVID-19 cases have recently decreased in Henry County, Ohio, it would be appropriate to continue to encourage mask wearing but to indicate that it would no longer be required for someone appearing before or at the Domestic Relations and/or Juvenile Divisions of this Court to wear a mask, unless the individual has not been vaccinated against COVID-19 or unless the individual is appearing for a drug/alcohol test.

Therefore, it is hereby **ORDERED** that, if an individual has not been vaccinated against COVID-19, he or she shall wear a mask during any time he or she is appearing before or at the Domestic Relations and/or Juvenile Divisions of this Court and, if an individual is appearing for a drug/alcohol test, he or she shall wear a mask at all times while undergoing the test, unless directed to remove the same by court personnel. Nevertheless, all individuals are encouraged to wear masks at all times.

The Court reserves the right to reinstate the mask mandate at any time should the numbers of COVID-19 cases in Henry County increase in the future.
